Overview and Scope
Your personal data privacy is important to us and CTS is highly committed in respecting and managing your Personal Data collected in line with this Policy.
This Personal Data Privacy Policy sets out the collection, use and disclosure of your Personal Data. "Personal Data" means any data or information, whether true or not, about an individual who can be identified either (a) from that data; or (b) from that data and other information to which CTS is likely to have access to. Personal Data excludes Business Contact Information which means an individual's name, position name or title, business telephone number, business address, business electronic mail address or business fax number and any other similar information about the individual, not provided by the individual solely for his personal purposes.
When and what kind of Personal Data do we collect?
CTS may collect, use and disclose the following data about you:
1. If you enter into any contract with CTS or purchase any products/services from CTS;
2. When you provide Personal Data by filling in online or offline forms when applying for CTS' services or feedback, asking queries, requests and submissions;
3. If and when you contact CTS, we may keep a record of that correspondence including emails, online chat logs, communications through social media and the possible recording of any telephone calls, you may make to us;
4. If and when CTS contacts you via referrals, we may keep a record of that correspondence;

6. If and when you respond to any of CTS' marketing promotions, newsletters and other materials;
7. When you fill up job application forms to apply for a job at CTS;
8. If you participate in any event, activity, promotion and special offer organised by or where CTS is a participant; CTS may collect the following kinds of Personal Data through the different channels mentioned above:
1. Name;
2. Date of Birth;
3. Residential mailing addresses (Local and Overseas);
4. Email addresses;
5. Telephone numbers (Residential and Mobile);
6. ID/Passport numbers and copies;
7. Nationality;
8. Emergency contact information;
9. Next of Kin or family information;

10. Death and Medical certificates and letters

11. Bank account details and credit card information, if necessary;
12. Photos and CCTV/videos;
Additionally, if you are applying for employment with CTS, CTS will collect the following:
1. Marital Status;
2. Gender;
3. Race;
4. Academic qualifications, educational and employment history and professional qualifications, including testimonials and references;
5. Medical, legal and financial history;
6. Photos; and
7. Curricula Vitae, if any.
What purposes does CTS Collect, Use and Disclose Personal Data?
CTS may use the information we collect from you for any of the following purposes:
1. To perform or carry out CTS' obligations arising from any contracts entered into between you and us (i.e. when you request or purchase a product or service offered by CTS);

2. To enable CTS' subcontractors, third-party agents, service providers, business partners, professional advisors and consultants to fulfil obligations/services as stipulated in your contract with CTS;

3. To handle requests and enquiries (including processing of payments and refunds, waiver of penalties and filing of insurance claims);

We may also contact you by any means of communication for which you have given us contact details, including but not limited to via email, telephone numbers, and post, for the purpose of getting your feedback or for providing you with information which we believe could be of interest to you or your organisation.

By your submission of your Personal Data to us, you consent to the onward disclosure of your Personal Data to these agents or service providers (as set out in no.2 of "What purposes does CTS collect, use and disclose personal data?") and the processing of your Personal data by these agents or service providers.

The countries in which these third parties are located will depend on the circumstances. In the ordinary course of business we commonly disclose Personal Data to parties located in Singapore. CTS may also disclose or transfer out of the country personal data as permitted or required by law. In the event any cross-border transfer or disclosure is required, we will take steps to ensure that the recipient organisation will take reasonable measures in the protection of your personal data.

Consent for the collection and use of my Personal Data

Does CTS disclose Personal Data to third parties?

CTS will not transfer Personal Data within or outside Singapore unless it is ensured that the Personal Data will be accorded a level of protection which is comparable to the protection under the PDPA.

For how long does CTS retain my Personal Data?

CTS will cease to retain Personal Data, as soon as it is reasonable to assume that the purpose for collection of such personal data is no longer being served by such retention, and such retention is no longer necessary for legal or business purposes.

Does CTS use cookies to collect and use Personal Data?
